CORONAVIRUS UPDATE

Vaccine for COVID-19

Following news on Monday of the progress made towards developing a vaccine, the Prime Minister gave his assessment in a press conference and outlined the Government's thinking as to how events might then evolve assuming the vaccine is approved. COVID-19 test roll-out

It was also announced on Monday that 600,000 rapid turnaround flow test kits will be issued to over 50 directors of public health across England this week to enable local teams to direct and deliver community testing based on their local knowledge. Each will receive a batch of 10,000 antigen lateral flow devices as part of a new pilot to enable them to start testing priority groups. For further details please see here: -

Businesses and venues during lockdown

BURY PARISH COUNCIL

Last week in our Newsletter we explained that we were liaising with the current hirers of the village hall to establish whether they could continue with their activities in the light of the need for community centres and halls to close under the lockdown restrictions. However, the rules do permit our hall to remain open for the purposes of provision of childcare and for education – consequently the Cornflakes and Chillout Club can continue operating. This is also true of the Boathouse Ballet School which provides education in ballet to a curriculum which prepares children for a structured series of UCAS-approved exams and as a consequence is regarded as a school as opposed to a dance studio (which would not qualify for exemption). So, we can at least continue to derive some income for the hall during the lockdown period and we hope to be welcoming back our other hirers in three weeks' time.

As mentioned last week, Bury Green and Playground remains open but please follow the guidelines you will find on the entrance gate.

Fortunately, as our post office is effectively detached from the village hall without direct access to it, there is no need to close it and Tracy has confirmed she will be in Bury every Friday afternoon as usual during lockdown from 1.15 to 3.15pm.
