### CORONAVIRUS UPDATE

On a national scale, with over 15.5 million first doses having been administered, the UK has now reached the mid-February target of offering a vaccine to everyone in the top four priority groups, which includes NHS frontline staff, care home residents and workers, over-70s, and people deemed clinically extremely vulnerable.

Invitations are currently being issued to those aged between 65 and 69 and the Government's aim now is by the end of April to vaccinate everyone over the age of 50 and all those aged 16 to 64 with certified underlying health conditions plus adult carers. All those who have had their first dose will receive a second within a 12-week period.

People in the 65-69 age group will now receive a letter from NHS England offering a vaccination at a mass vaccination centre. Chichester District Council have announced that an additional centre at the Westgate Leisure Centre in Chichester is about to be added to the list.

If you are member of the 65-69 age group and are a patient at the **Pulborough Medical Group** but would prefer not to attend a mass vaccination centre, you can ring PMG now and book an appointment to have your jab at the surgery – please note they will not be contacting these patients. PMG are also offering vaccines to patients aged 16-65 in an “at risk” group and they will be contacting these patients during the coming days. ## **SUSSEX POLICE UPDATE**

At the recent Chichester All Parishes Meeting, Chief Inspector Jon Carter provided details of crime data for the county during 2020. ## **TREE FELLING – A29 BURY**

Following the Ash Dieback work in January resulting in the loss of two thousand trees, Bury Hill looks somewhat bare and untidy in parts. Mike Simpson has been in contact with West Sussex County Council in relation to any plans for replanting. However, due to financial constraints it seems that WSCC prefer the natural regeneration solution. The following is the response from the Ash Dieback Project Manager: -

*‘Now that the ground has been opened up to light, natural regeneration will take place. The advantage of natural regeneration is that the seed source is already well adapted to the soils and moisture regimes specific to that local environment. For further information, you may find [this website](#) of interest.*

*Should the funding be made available for replanting, to ensure the replacement planted trees successfully establish, a programme of ongoing management and watering would be needed during the 3-5 year establishment period. Replanting also introduces other environmental hazards such as plastic waste through the need to use tree guards during the establishment phase. Also, the time for replanted trees to reach maturity will not be dissimilar to the time for natural regeneration to take place and reach maturity.*

*An additional consideration for this particular site that has now been brought to my attention is the presence of chalk grassland and the opportunity afforded by the recent felling works to address ash dieback for restoring this area of chalk grassland.’*

Bury Parish Council await to hear back about the extent of the felling and if there are plans for any more.

## **PLANNING APPLICATION – PAW PADDOCK**

Towards the end of last year an application was made for the creation of a dog exercising compound in a field in Houghton Lane. This met with considerable opposition from a number of residents in the parish and we have now heard that the application has been withdrawn.

## **FALLEN TREES – BURY HOLLOW**

A pair of trees high in the bank behind Appletree Cottage in the Hollow have toppled over to almost 90 degrees and now sit precariously above the road creating a possible danger to pedestrians and traffic should they suddenly fall further. As these trees are lying on the overhead electric lines, they were reported to SSE by Bury Parish Council a couple of weeks ago - BPC have now contacted SSE again (Feb 16<sup>th</sup>) who have promised to attend to this soon.

## **DOG FOULING**

Following our report on 3<sup>rd</sup> February on dog fouling in Bury, it is disappointing to note that the problem persists and attempts are being made to identify the owner responsible. Failing to clear up after a dog is against the law and Chichester District Council Enforcement impose a fine of £100 for the offence (reducing to £75 if paid within 14 days). If fines are not paid and a case goes to court, the maximum penalty for dog fouling is £1,000.
